



## UNIVERSITY OF FLORIDA BOARD OF TRUSTEES RESOLUTION

**WHEREAS**, Curtis Reynolds has been a trusted leader at the University of Florida since 2010, serving as Vice President for Business Affairs providing strategic direction of a diversified portfolio of campus business and support services, and

**WHEREAS**, Mr. Reynolds has oversight of the divisions of Business Services; Environmental Health and Safety; Emergency Management; Campus Planning, Design and Construction; Transportation and Parking Services; Physical Security; Emergency Management; the Office of Sustainability; Facilities Services; Small Business and Supplier Diversity; the Stephen C. O'Connell Center; the UF Police Department, and

**WHEREAS**, Mr. Reynolds orchestrated UF's Capital Improvement Programs over the span of 10 years, resulting in more than \$2.7 billion in construction activities, creating over 5.9 million gross square feet of campus spaces and countless remodeled/renovated buildings; championed six campus Energy Performance Contracts, resulting in \$47 million in guaranteed savings and the elimination of \$62 million in deferred maintenance and/or avoided operational cost; charted the course for UF to be a national leader with 100 green building certifications, including Malachowsky Hall and the Student Health Care buildings, which are on track to be UF's first platinum-level certification; negotiated some of UF's highest supplier services contracts, including Duke Energy, Pepsi, and Chartwells, and


**WHEREAS**, Mr. Reynolds is seen as a trusted and authentic leader who values the more than 1,400 employees under his direction, and who established or developed the Career Progression Program for Facilities skill trades for increased recruitment and retention; high-performance work teams across campus for proactive customer service and minimized outages; strong collaborations with multiple academic departments to assure sustainable preeminence in operations and the Elite Gator award to recognize individuals with exemplary service, safety records and sustainability, and


