Chairperson O'Connell called the meeting to order at 2:04 p.m.

Trustee O'Connell asked Dr. Telles-Irvin to give an overview of the Student Conduct Code and Student Honor Code since the September 5th Board of Trustees (BOT) meeting, as reflected in the package circulated to the Committee dated September 12, 2008. After Dr. Telles-Irvin gave her brief overview, Trustee O'Connell asked Trustee Reilly to give Student Government's view of the changes. Trustee Reilly stated that Student Government is pleased with the draft and feels that most of student recommendations have been incorporated into the current draft.

General Counsel Keith listed the current regulatory sections proposed to be repealed (4.013-4.026), and within those sections, the provisions to be amended and renumbered (4.0162, 4.0212, 4.022), and the one section to be retained (4.0161), as well as the new sections proposed to be adopted, noting there are a few technical proof-reading corrections:

Trustee McGriff made a notion to approve the repeal and renumbering and amendment of current regulations and the adoption of the new regulations as summarized by Ms. Keith.

Trustee Ponce seconded the motion, and the Regulations were approved by the committee unanimously.

Vice President Keith stated there was a small amendment to the proposal attached to the internal operating memo ("Joint Proposal of Student Government and Student Affairs Concerning the Honor Code Chancellor and Vice Chancellors") to make the proposal consistent with the IOM. The change permits vice chancellors to advise students and serve on conduct committees as long as the same individual does not serve in both roles for the same conduct case.

Trustee Ponce noted that implementation of the IOM is a work in progress and asked that a status report be given on how the process is coming. Trustee O'Connell asked Trustee Reilly to give a progress report at the December BOT meeting.

Trustee Ponce made a motion to approve the internal operating memo, Trustee McGriff seconded and the motion passed unanimously.

Trustee Ponce thanked Dr. Telles-Irvin and Dr. Zdziarski as well as all the staff, Trustee Reilly and Student Government for working through this process and commended everyone for all their efforts. Other committee members agreed and gave their thanks.
